

C&G's HERITAGE FARMS, LLC PHOTOGRAPHY POLICIES & RULES

Any and all professional or amateur photographers and their clients (Photography Group) must understand and adhere to the following policies and rules, which have been established to allow an enjoyable experience for all our guests visiting the farm.

We do, however require a modest fee and a signed Acknowledgement & Waiver Agreement for each photographer. Safety is our main priority. Therefore, all photographers must complete and return to Heritages Farms Request and Agreement and Waiver Forms with payment before entering the farm or you will need to reschedule the session(s).

Please complete the online Request Form or you may contact Adam Pernet at adam@heritagefarms.com with your proposed date(s) and time(s) and Adam will respond with what the Farms available dates and times are.

Heritage Farms Policies and Rules:

- No pets are allowed on the farm except service animals, but pets may be considered with prior approval. Proof is required pets are up to date with their rabies vaccine and must be on a leash at all times while on property. Please contact us for prior approval and to determine any additional requirements for pets.
- Absolutely no vehicles are allowed in the fields at any time.
- No smoking is permitted in the tree fields, this includes the use of vaporizers.
- Clients/models must be fully and appropriately clothed (i.e., no nudity, swimsuits, lingerie, etc.)
- Photographers must request permission before setting any client dates or arriving at the farm.
- Photographers must complete the Heritage Farm Photography Request, Agreement, Acknowledgement & Waiver Agreement and payment before setting any client dates.
- Photography Session Fees are due before or upon arriving at the farm.
- Email the farm for availability and permission to be considered.
- Permission is given on a single-day basis. Please complete a separate application for any additional days you wish to request.
- We reserve the right to limit the number of photographers on any given day and time.
- Any use of commercial screens, external power sources, panels, backdrops, props, commercial lighting, or other professional equipment must be detailed in the photography application and pre-approved
- Photography is permitted only in the tree fields. Please stay out of the woods and farmhouse area.
- Do not remove any tree tags or signs at your site.
- Do not leave any personal items unattended, we are not responsible for anything lost, broken, stolen, or left on the farm.
- Photo shoots must not block any farm activities such as customers, paths, trails, equipment, buildings, etc.
- Respect and be aware of other farm customers and what is going on around you. This is a working farm so there are often tractors, machinery, and other work happening.
- Respect the work and space of other photographers who may around the farm.
- Tree farm staff reserve the right to ask you to leave the farm at anytime.
- Those not following this policy may be asked to put away their equipment or leave the farm.

Restrictions

- Photography/video to be sold as Stock photography/video is NOT permitted at Heritage Farms without a separate agreement.
- Film/video of product, business commercials or promotional materials are NOT permitted at Heritage Farms without a separate agreement.

Heritage Farms Amenities:

- There is an area in our Harvest Barn where Photography Groups can meet or rest complete with mirrors and complementary coffee, tea and water may be available depending on the season.
- There are no public restrooms available for use but we do have Port-A-Potties for our guests.
- Parking is available for Photography Groups in the main parking lot.
