VENDOR APPLICATION & MARKET INFORMATION



The Peninsula Flea is a rustic outdoor market hosted at Heritage Farms in Peninsula, Ohio. As with previous years, this year will feature handcrafted decor, homemade snacks and baked goods, repurposed items and vintage finds, and informational kiosks for area non-profit groups. The Peninsula Flea at Heritage Farms strives to offer high-quality items from dedicated artists, craftspeople, and collectors, all of whom are proud to call Northeast Ohio their home!

In 2024, Heritage Farms will continue our over-175 years of service as a family-owned and -operated establishment, catering to a wide variety of guests and hosting a wide range of seasonal events. Located at 6050 Riverview Road in Peninsula, Ohio, we are situated comfortably among the scenery of the Cuyahoga Valley National Park. We will host the Peninsula Flea during the summer months of 2024, on the first and third Saturday of each month—specific dates will be featured below in the available **Options and Pricing Details** section of this application form.

WHAT WE OFFER

Indoor and outdoor spaces will be available for rent for all markets, with an early application discount available until April 1, 2024. From April 2, 2024 onward, all vendor sites will be available at their standard rates.

Indoor spaces, measuring 8' x 8', are available in our historic Harvest Barn and in the Tree Barn—**there are a limited number of indoor spaces available**. Pricing information is listed below. We also have four outdoor spaces with access to an electrical hookup—**electrical access for indoor and outdoor spaces is \$10.00 per market**. Indoor and outdoor options are to be marked by vendors in the application section below—specific site positions will be decided at the discretion of the Flea Market staff.

We happily welcome Food Trucks to the Peninsula Flea and charge a flat rate per market all-season, before and after April 1, 2024, to accommodate variable availability.

GUIDELINES FOR PROSPECTIVE VENDORS

Vendors may sell only the items listed on their application. We strive to host a well-balanced market and can only maintain said balance if we know exactly what each vendor is offering.

No vehicles will be allowed in the vendor area after setup. Separate parking will be provided for all vendors at the top of the driveway. Vendors and their associated staff are not permitted to park in customer parking.

Vendors are expected to provide their own tent, tent weights, merchandise, displays, tables, chairs, etc. All tents must be weighed and secured to the ground. All vendors must present a professional display. Excess boxes, bins, and products must be stowed in the vendor's vehicle or out of view of the general public. Prices/pricing criteria must also be easily visible by the general public.

Direct sales and mass-produced items are not permitted.

There is no smoking allowed at vendor sites. Designated smoking areas near the grass parking lot and the gravel parking lot are available.

Music is not permitted to be played at vendor sites nor within flea market grounds. Live music performed by local musicians is provided.

Portable toilets are available for use by vendors, staff, and guests alike.

Early setup is available the evening prior to any of the listed markets. Please contact in advance to ensure the vendor sites have been marked before arriving early. Early setup may begin no earlier than 3:00 p.m. and is to conclude no later than 7:00 p.m. the day before any of the listed markets. **There will be no staff available to assist with early setups on Fridays.**

On Market days, vendors are expected to arrive and get set up between 7:00 a.m. and 9:30 a.m. Vendors will be able to unload within 50' of their site. Hand carts are available for further transport. **We open for business at 10:00 a.m. and close at 4:00 p.m.** Vendor site teardown is to begin following the 4:00 p.m. market closure, **not before.** Vendors are expected to clean their space completely; pack away their wares, tents, and displays; and clean up, dispose of, and take home all trash from their sites.

DISCLAIMER: The Peninsula Flea is a "rain or shine" market, and Heritage Farms is an outdoor venue. No refunds will be issued if an individual vendor cancels due to rain; however, should the market be canceled in its entirety due to weather, refunds will be issued.

Any vendor who does not comply with the information listed in the paragraph above may be subject to exclusion from future markets and other Heritage Farms events.

We appreciate your time in reviewing and following the guidelines for the Peninsula Flea. We look forward to hearing from you and, more importantly, seeing you during the 2024 Peninsula Flea summer season!

We offer a variety of options and prices for Vendor Sites based on your personal and business needs. We accept payments in the form of cash, check, credit and debit card, and PayPal—an additional service charge will be incurred for PayPal transactions.

All PayPal transactions are to be submitted to carol@haramis.com—please include your name, your business’s name, your email and phone contact information, and the market dates you are paying for. If paying by check, your space will be assigned only when the check clears.

Checks should be made payable to C&G’s Heritage Farms, LLC. Checks that bounce will incur an additional \$10.00 fee. Specific vendor spaces will be decided at the discretion of the Heritage Farms staff upon receipt of payment.

A Six-Market Bundle is available to vendors who plan to attend all markets during 2024. This bundle includes a total discount of \$25.00. Discounts are valid only if the Six-Market Bundle is selected before the April 1, 2024 deadline.

Please note: Preseason applications for individual markets and for the Six-Market Bundle must be submitted on or before April 1, 2024. Applications will be reviewed swiftly to ensure proper qualifications for preseason discounts.

SITE PLACEMENT IS AT THE SOLE DISCRETION OF THE MARKET MANAGER.
