

2023 PENINSULA FLEA AT HERITAGE FARMS

VENDOR APPLICATION & MARKET INFORMATION



The 2023 Peninsula Flea at Heritage Farms is an upscale market, featuring handmade, handcrafted, repurposed and vintage items. Heritage Farms strives to offer high quality items from dedicated artists, crafts people and collectors.

Heritage Farms is celebrating 175 years as a 5th generation family-owned farm. We are located in Peninsula, Ohio at 6050 Riverview Road. The PENINSULA FLEA will be held each month on 6 Saturdays from June to September. **Market dates will be JUNE 3rd, June 17th, JULY 1st, July 22nd, AUGUST 5th, and SEPTEMBER 2nd, 2023. Market hours are 10:00am to 4:00pm.**

The July 22nd market will be part of the **Heritage Farms Christmas in July** event.

Indoor and outdoor spaces will be available to rent for all markets. Vendor site assignments are at the sole discretion of the Market Manager, Carol Haramis. Vendors will be responsible for providing their own 10'x10' awning or tent and their own display, tables, chairs, tent weights etc. Indoor spaces are available in the historic Harvest Barn and in the Tree Barn. Indoor spaces are 8'x8'. There are limited number of indoor spaces available. There are 4 outdoor spaces with access to an electrical hook up. Electric access is \$10.00 per market. The Market Manager will decide what site a vendor is assigned.

Vendors may sell only the items listed on your applications. We work very hard to have a well-balanced market and can only do that if we know exactly what each vendor is offering.

No vehicles will be allowed in the vendor area after set-up. Separate parking will be provided for all vendors. **No vendor, helper or staff will be allowed to park in customer parking.**

Direct sales and mass-produced items are not permitted. All vendors must present a professional looking display, with no visible piles of excess boxes and bins. These items must be returned to your vehicle or hidden under your skirted tables. All items must be clearly priced.

Rental fees: Vendor fees for all markets are due no later than April 1, 2022. THERE ARE NO REFUNDS.

\$65.00 for a 10'x10' outdoor space or for an 8'x8' indoor space. \$68.00 if paying with PayPal

\$100.00 for a 10'x20' outdoor space. \$105.00 if paying with PayPal.

No double space is available in either barn.

\$95.00 per day for FOOD TRUCKS. \$100.00 if paying with PayPal

AFTER April 1, 2023 ALL SITES ARE: \$88.00 per market for a 10'x10' or 8x8 space and \$130.00 for a 10x20 space. and are due upon acceptance and paid through PayPal only.

ONCE YOU ARE ACCEPTED AS A VENDOR: Fees for all markets you have been accepted for MUST be paid in full by April 1, 2023. In order to receive the 6 market \$25.00 discount, you must pay in full for all 6 markets no later than March 1, 2023. DO NOT SEND PAYMENT FOR ANY MARKET UNTIL YOU ARE ACCEPTED AS A VENDOR.

PayPal is available with an additional fee PER MARKET to cover the fee charged by PayPal, see the Rental Fees section above. Please send PayPal payment to carol@haramis.com. Include your name, business name, the dates you are paying for and your contact phone number.

We accept checks, cash or PayPal payments. Credit card payments are available through PayPal. If you pay by check, you will not be assigned a space until your check clears. Vendor spaces are assigned only after payment is verified. This is a rain or shine market. Fees will not be returned or credited for any reason if you do not attend.

We are pleased to offer spacious grounds with a beautiful farm setting. Our parking is free for both vendors and customers. Vendors are able to unload and load within 50 feet of your site. We also offer carts and Heritage Farms staff to help. Friday afternoon and early evening tent and table only set up is available from 3:00pm to 7:00pm the day before a market. **THERE WILL BE NO staff available to help with set up on Fridays.** Clean porta johns are located close to the flea market area. Set up is the day of the event. Vendors may arrive no earlier than 7:00am and must be completely set up and ready to sell by 9:30am. Tear Down IS NOT to begin until after the market closes at 4:00pm and must be completed by 5:00pm. **Any Vendor who packs up early could be excluded from future markets.** Vendors are responsible for tear down and taking home of ALL trash from your space.

Please submit your completed application as well as 3 recent photos and a link to your Facebook page and website. **Applications without photos will not be considered.** Spaces are limited.

THE PENINSULA FLEA, C&G'S HERITAGE FARMS, LLC, IT'S OWNERS, EMPLOYEES AND VOLUNTEERS WILL NOT BE RESPONSIBLE FOR ANY DAMAGE, THEFT OF PERSONAL BELONGINGS, VEHICLES OR MERCHANDISE OR OF ANY PERSONAL INJURY WHILE ON HERITAGE FARMS PROPERTY. VENDORS MUST BE RESPONSIBLE FOR THEIR OWN VENDOR SPACE AND MUST CARRY THEIR OWN INSURANCE. ANY ACCIDENTS OR DAMAGE CAUSED BY A VENDOR OR VENDOR'S SET UP OF GOODS WILL BE THE RESPONSIBILITY OF THAT VENDOR.

SMOKING IS NOT PERMITTED AT VENDOR SITES. NO MUSIC ALLOWED IN THE BOOTH SITES. NO DOGS ALLOWED. VENDOR SITE ASSIGNMENT IS AT THE SOLE DISCRETION OF THE MARKET MANAGER. A FULL LIST OF MARKET RULES WILL BE SENT TO ACCEPTED VENDORS ONCE PAYMENT IS RECEIVED.

VENDOR FEES: UPON ACCEPTANCE, VENDORS NOT TAKING ADVANTAGE OF THE PAY IN FULL 6 MARKET \$25.00 DISCOUNT OPTION, MUST HAVE VENDOR RENTAL FEES PAID NO LATER THAN APRIL 1, 2023. BEGINNING APRIL 2, 2023, SITES WILL THEN BE FILLED ON A FIRST PAY BASIS AT \$88.00 PER AVAILABLE 10x10 or 8x8 SITE or \$130.00 FOR A 10x20 SITE PAYABLE THROUGH PAYPAL ONLY. SITE ASSIGNMENT IS AT THE SOLE DISCRETION OF THE MARKET MANAGER.

REFUNDS: THERE ARE NO REFUNDS FOR DATES YOU DO NOT ATTEND. WE EXPECT ALL VENDORS TO ATTEND ANY AND ALL DATES THEY HAVE PAID FOR AND COMMITTED TO. WE WILL ONLY PROMOTE PAID VENDORS FOR EACH FLEA EVENT.

SALES TAX: ALL VENDORS ARE RESPONSIBLE FOR ABIDING BY ALL TAX LAWS AND FOR COLLECTING AND REPORTING THE 6.75% SALES TAX FOR SUMMIT COUNTY AND SECURING THE PROPER PERMITS REQUIRED BY LAW.

THE PENINSULA FLEA AT HERITAGE FARMS HAS THE RIGHT TO DENY THE PARTICIPATION OF A VENDOR IN ANY OR ALL OF THE EVENTS AT ANY TIME. SHOULD THERE BE A REASON TO REVOKE YOUR ACCEPTANCE PRIOR TO THE DATE OF THE EVENT, A FULL REFUND WILL BE GIVEN UNLESS ANY OF THE GUIDELINES STATED IN THE 2023 MARKET RULES HAVE NOT BEEN FOLLOWED.
